

## **Consultation response report**

# **Proposal to change the name of Whipton community hospital to Exeter community hospital (Whipton)**

October 2011

## 1. Background and context

In July this year, the Trust was contacted by Whipton hospital League of Friends and the issue of a possible name change for the hospital was raised.

Whipton hospital League of Friends was set up earlier this year by NHS Devon, who provided funds to establish a charity to support Exeter after many years without a League.

Over several months, the League heard from a wide range of staff, patients and visitors at Whipton hospital that the name 'Whipton' did not reflect the whole catchment population served by the hospital. In addition, people felt that it was not consistent with the Trust's 16 other community hospitals, which are all named after the town in which they are located.

The consultation therefore proposed changing the name, in the interim, to Exeter community hospital (Whipton), with a view to removing the Whipton reference after 12 months, once stakeholders and patients are familiar with the new name.

## 2. Methodology

A letter with details about the proposed consultation and a response sheet asking for people's views and comments about the proposed name change were sent to a comprehensive list of stakeholders (see appendices 1, 2 and 3).

A press release was sent to the local paper, the Exeter Express and Echo, informing the public of the consultation and including details of how to give feedback.

The letter and response sheets were posted on all staff noticeboards and in communal staff areas around Whipton hospital. The consultation was also discussed at all team meetings both at the hospital and in the local community. In addition, copies of the letter and response sheet were placed on public noticeboards in each ward for staff, visitors and patients to see.

Details about the consultation were posted on the Trust's website and intranet, with links to the response sheet, in order to make completing the form as easy and quick as possible for staff.

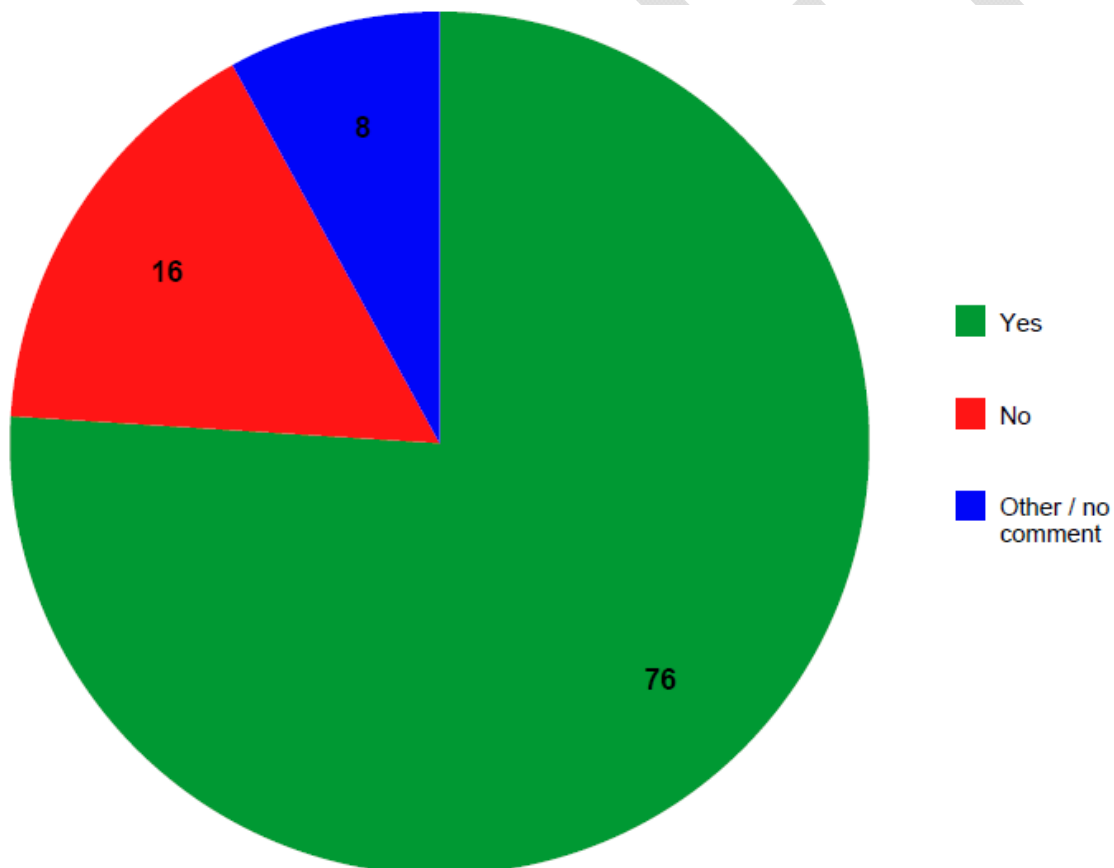
A brief paragraph with a link to the letter and response sheet also appeared in the weekly Chief Executive's Bulletin which is sent to all staff across the Trust.

The consultation ran from 23 August to 30 September 2011.

### 3. Findings

A total of 74 responses were received which are shown in appendix 4. The responses can be broken down as follows:

Yes, the name should be changed:	56	(76%)
No, the name should stay as it is:	12	(16%)
Other / no comment:	6	(8%)



A snapshot of the comments received are overleaf:

## Pro- name change:

- “We need to ensure that stakeholders and patients are aware that we are a community hospital in our own right serving the Exeter area and not an off-site ward of the RD&E. Hopefully a name change would help towards this.”
- “With all the other community hospitals in the trust reflecting the towns/areas they serve it makes sense to rename the hospital to make it clearer for patients and the wider healthcare community.”
- “I feel the population that we serve does not realise that Whipton is their community hospital - they think it just serves Whipton. The name change would give us a proper identity as Exeter's community hospital.”
- “It would be lovely to have the same relationship with our local community that other hospitals, such as Sidmouth, Honiton and Exmouth, have.”
- “The hospital accommodates everyone in the Exeter area – not just Whipton. Therefore, a change of name would be appropriate – to try to gain support.”
- “Other community hospitals have the town name in their title, and as our catchment area stretches as far as Starcross it makes sense.”

## Anti- name change:

- “I think it may take longer than 12 months for the local community to acknowledge the hospital as Exeter as opposed to Whipton. May I suggest a 2 year period with the reference to Whipton.”
- “Why spend money on this change that people will still refer to Whipton Hospital for many years to come.”
- “I feel that changing the name could confuse a lot of people.”
- “A change of name includes many hidden costs which would be of better use for patients and staff.”
- “I don't think it really matters whether the name is Exeter community hospital or Whipton. North Devon District Hospital's name reflects its catchment area but is still referred to as Barnstaple Hospital by many patients (and staff) as this is its location. If the name is changed, some will still call it by the old name as it denotes its location.”

## 4. Recommendations

As a result of the overwhelming support as shown in the consultation responses, the Trust proposes that Whipton community hospital should go ahead with the name change.

The Trust therefore proposes that the name is initially changed to Exeter community hospital (Whipton), with a view to removing the Whipton reference after 12 months, once stakeholders and patients are familiar with the new name.

The Trust's estates department will arrange for all signage on the hospital premises to be replaced with the new name. It is anticipated that this work will commence in xxxx

A copy of this report and a letter confirming the name change will be sent to all stakeholders who took part in the consultation. Notices will also be placed in the local press, on the Trust's website and in the Chief Executive's Bulletin.

In order to minimise the cost implications of the change, it is suggested that all stationery is used up before new supplies are ordered with the new name.

I am writing to request your feedback on a proposed name change of Whipton community hospital in Exeter. Our staff have requested this change and we would like to hear your views.

In addition, I would formally like to launch the new hospital League of Friends charity at this site.

Whipton community hospital is Exeter's only community hospital and serves all of Exeter's residents with a wide range of in-patient and rehabilitation facilities. It has two wards, Budlake and Poltimore, which are located in separate buildings on the large site. The hospital has a total of 39 in-patient beds.

The hospital also provides valuable links with teams in mental health, social services and the voluntary care sector. The hospital cares mainly for older patients, most of whom transfer from the RD&E hospital following an episode of acute health care such as a medical emergency, operation, fall or fracture. The average age of patients is 85, meaning that care is often provided to patients with complex mental health needs, such as dementia, alongside other physical health problems.

With all this in mind, the Trust feels that the name 'Whipton' does not reflect the whole catchment population served by the hospital. We therefore propose changing the name, in the interim, to Exeter community hospital (Whipton), with a view to removing the Whipton reference after 12 months, once stakeholders and patients are familiar with the new name.

In addition, and with the launch of the new League of Friends at the hospital, we are keen to generate new interest and strong local ownership of the hospital and help support any of the League's fundraising activities by placing a greater emphasis on the hospital as being city-wide.

The League of Friends will work in partnership with the hospital to raise funds, provide volunteers and act as a bridge with the local health community, in order to enhance and improve the service that we deliver to our patients, staff and visitors.

We would like to reassure you that the change of name will not affect any of the services the hospital provides to its patients, staff and visitors and that the main priority will continue to be the delivery of excellent healthcare.
